Sailing Illustrated commentary

During our Executive Session at the Board meeting in London, Kim Andersen pointed out that there were some inaccurate comments expressed by the Sailing Illustrated host, Tom Ehman, attributed to me and Scott Perry. A draft letter was presented asking Tom Ehman for an apology. I stated that I would have to hear what was said on the program before I sent a letter to Mr. Ehman and that I would use the transcription to refute any inaccurate information. I have now listened to the program that mentions me. Tom Ehman is the narrator and here is the transcript from his program:

"I think US Sailing has been weak. The rest of the world looks to US Sailing, the RYA, the Australians, and a few other countries like the Germans and the Spanish, and so on. It's up to US Sailing to lead, and the US is sitting around. It looks like they are twiddling their thumbs. They are not strong. I know behind the scenes that Gary Jobson, who is an American and a Vice President, he was very helpful of getting rid of the non-sailing CEO. There I said it. I know he agrees with what I am saying, but he won't say it publicly because World Sailing, like US Sailing, which I criticize for having secrecy."

This is the only reference about me that I found in the 1 hour and 42 minute program. Scott Perry is not mentioned anywhere in the program. There is a reference to Scott MacLeod, who is a marketing manager for the New York Yacht Club's America's Cup challenger, "American Magic." I see no reason to demand an apology.

Dear board,

There has been a lot of back and forth stemming from Sailing Illustrated that is causing confusion in our board and now in our sport.

As mentioned last week, I received inputs from members of the sailing community that Sailing Illustrated were referencing two of our board members as sources that were giving information about World Sailing. I later heard the session myself and came to the same conclusion, believing that this media were misinformed and wrongly using members of our board.

In order to protect these individuals, the board and World Sailing I wrote to you before the board meeting about this topic so that we could discuss it together. (See attached letter 1)

As discussed in the board meeting when we addressed this point, we agreed to draft and send a letter stating that Scott and Gary were not the source claimed in this media and did not appreciate the attack on WS and them. We agreed that I would draft the letter and forward it to the board, then upon receiving feedback on the letter it would then be sent.

The draft was done and sent to you all that same evening. (See attached letter 4)

The next day, during the board meeting, I received an amended letter from Scott with no further instructions (attachment 2, see attached Word document – the amended letter). There were no additional amendments or feedback from the board, therefore after the board meeting the amended letter was forwarded to the WS office for release (attachment 3).

I did what we agreed and I did it to protect our board members and World Sailing.

I hope this clarifies the situation, and that we can continue working together to deliver good work for our sport.

Dear Sirs

As you are aware, we are instructed by Mr Andersen in relation to an internal investigation in respect of our client pursuant to the World Sailing Code of Ethics.

We are surprised to learn of what, on first blush, appear to be steps taken by World Sailing, which do not accord with principles of natural justice or fairness. Despite Mr Andersen drawing his concerns to your attention, these have not been addressed in a satisfactory manner and we have advised our client that these should be fully, <u>before</u>any Ethics Officer reviews the complaint and our client's response to the complaint.

We first of all note that pursuant to Regulation 36.4 any complaint should have been made to the Chief Executive Officer who shall consider whether to refer it an Ethics Officer. We note that this did not occur, as a Chief Executive Officer was not in place at the time and instead the Ethics Commission itself appointed Josep M Pla as the Ethics Officer. Given the importance of the Ethics Commission retaining its independence to properly deal with any prosecutions, there is a legitimate reason why it should<u>not</u> be involved in the appointment of what is effectively the Prosecutor.

Further we note that this decision runs totally contrary to a recent appointment of an Ethics Officer, where the decision of the Chair of the Ethics Commission was to out-source the appointment to an independent body, Sport Resolutions, to appoint an Ethics Officer that had no connection whatsoever to World Sailing, the complainants or those subject to that complaint. A London based barrister was appointed.

With no CEO in place, we suggest that there would have even more reason to utilise their services again.

This is however compounded by the fact that our client expressed his concerns regarding the independence of the Ethics Officer who was appointed by the Ethics Commission.

As per the correspondence that he shared with you all on 4 May 2020, Mr Andersen was concerned that his disagreement with the Ethics Officer and the Ethics Officer's alignment to a rival candidate for Presidency of World Sailing could result in a conflict of interest and he duly raised concerns regarding the perceived impartiality of the Ethics Officer.

In line with natural justice, we would have expected these concerns to be put to the Ethics Officer for him to address them directly. However, Mr Andersen's concerns were instead summarily

dismissed by Mr Neupert the very next day, on 5 May, who regarded them as an *'interference with the procedure'* and the Ethics Officer himself has made no response to Mr Andersen's concerns. It is not clear whether Mr Neupert came to this decision alone or whether he consulted the entire Ethics Commission, however we can see they were copied into his response.

We therefore formally request that our client's concerns are put to the Ethics Officer and that he provides a written response as soon as practicable to confirm whether he considers there is indeed a conflict of interest (or if not, why not) and whether he believes he can act with total impartiality. We would also be interested to hear from the Ethics Commission as to the wisdom of it appointing Mr Pla as the Ethics Officer, when there is the potential for that individual to then prosecute a case before his appointor, with the right to ultimately appeal against decisions of that body.

In the interest of fairness, we also request that the deadline of 15 May (we note the offer to extend this to 18 May) for the submission of our client's response be <u>suspended</u>pending the resolution of this matter. Please note however, that we have already collated the entire response to the complaint and will be ready to provide that to any Ethics Officer on a day's notice. This correspondence should not be seen as an *'interference with the procedure'*, rather our client has every right to have his concerns dealt with properly and a right to a fair and independent procedure.

We note that Mr Neupert has suggested that our client may complain to the Council as reporting authority for the Commission (Reg 8.14.6) and our client reserves his position to do this, if he feels that his legitimate concerns regarding the independence and impartiality of the Ethics Officer and his appointment cannot be satisfactorily addressed pursuant to this correspondence.

Whilst our client is prepared to exhaust all administrative remedies, he expressly reserves his right to ultimately have matters determined by the Courts of England and Wales by application of English law if he considers that the procedures followed in this important issue are flawed. Sports ethics and disciplinary issues form the foundations of good governance of sport and cannot be dealt with in a vacuum, without due regard to the principles of natural justice.

We trust however, that this is not necessary and that the requested steps can be taken to address our client's valid concerns.

Thank you for your Decision below.

Whilst we did request a stay (and we note that this has been rejected), there was no formal application being made last week to the Ethics Commission. We had thought that it was clear that we were seeking clarification regarding the process that has been followed in relation to the Complaint against our client. We were looking to deal with this by correspondence, however, this is now the second time that you have largely disregarded the key issues.

As such, please now accept this email as a formal application that the Ethics Commission can consider and render a decision upon.

Our application is that the Ethics Commission, pursuant to World Sailing Regulation 8.14.8 (f):

(a) remove Mr Josep Pla as Ethics Officer; and

(b) appoint Sport Resolutions to duly appoint an independent replacement ethics officer.

The grounds for this application are:

1. It is unclear from World Sailing's Regulations and Code of Ethics who is to make such an appointment. Regulation 36.4 suggests that this should be done by the CEO, but then Regulation 36.5 classes the Ethics Officer as "an official appointed by the Ethics Commission". We note that the changes to World Sailing's Regulations appear to have been made in 2019, but have left untouched Regulation 8.14.8 (f). It appears to us, that the intention is that the CEO choses the ethics officer and makes the referral, but that appointment is done by the CEO on the Ethics Commission's behalf. Your email to our client dated 25 April 2020 confirms that you acknowledged that "there are some contradictions between Regs. 8.14, 35, 36 and our Rules of Procedure".

2. It is our position that an appointment by the body that will then hear any case by an ethics officer lacks good governance, independence and is against the rules of Natural Justice, as set out in our previous email. You have not addressed this point.

3. What has also not been addressed by you or therefore been disputed, is that the only other instance of a complaint being received and referred to an ethics officer, was the one from last year against the then CEO and our client. The process adopted was to utilise the services of Sport Resolutions, to give the process the necessary degree of independence. Please be aware that the ethics officer so appointed worked on a pro bono basis, as Mr Pla has agreed to do. Please address in you decision why you decided to ignore this process.

4. With the Complaint at hand, it is against the President of World Sailing and has been brought by two Vice Presidents (both copied in). This situation again concerns Board members and the previous precedent of utilising the services of Sport Resolutions should have been followed. 5. Whoever and however appointed as ethics officer should be conflict free, be able to act impartially and independently. We note that Regulation 35.6 provides some examples of people that would be conflicted, but that should not be the end of the list. The Rules of Natural Justice should ensure that the ethics officer considering the complaint at first instance should be conflict free, impartial and independent vis-à-vis the parties to the complaint (be that those making the complaint or those facing it). We refer you to the IBA Guidelines that are frequently applied by members of sports tribunals. It would be good governance to have checked with Mr Pla whether he met the terms of these in the light of the initial correspondence from our client and its attachments, dated 4 May 2020.

6. It may be that Mr Pla has been afforded the opportunity to comment on the issues raised by our client, but then any response should have been shared with our client, as we are openly keeping Mr Pla in copy.

7. We further rely upon the contents of that said correspondence and the attachments from our client dated 4 May 2020 and upon the email we sent to you on 14 May 2020, which appears below.
8. Again, we repeat this has nothing to do with delaying the process, no stay is being sought from you.

We await the decision of the Ethics Commission, duly grounded and containing full details upon how any affected party may appeal, should the same be necessary.

I herewith acknowledge receipt of your submission on behalf of the Ethics Commission May I once more point out the following:

The right to appoint the Ethics Officer

- Reg 36.4 states that the CEO "shall refer [any complaint] to an Ethics Officer". It does not suggest that the CEO shall play any part in selecting the said Officer.
- Conversely Reg 36.5 is explicit that "An Ethics Officer is an official appointed by the Ethics Commission."
- Reg 8.14.8 (f) is equally explicit: "(The Commission shall) appoint and remove Ethics Officers."
- In Regulation 35 a similar procedure applies, Reg 35.6.12 specifies that the complaint shall be passed by the CEO to the Judicial Board, and the Judicial Board shall appoint a Disciplinary Investigating Officer.

The Appointment by the Body that will hear the Case

The procedures of the Ethics Commission closely follow those prescribed for the Judicial Board where the Board appoints both the Disciplinary Investigating Officer (Reg 35.6.12) and the "Independent Panel" (Reg 35.6.19)

Therefore the Commission will not hear your appeal

Hi Josep

Good to talk the other evening - I am not optimistic of a face to face meeting for World Sailing for the rest of the year however.

I was reflecting on our conversation and the questions you asked me about the letter being sent to Sailing Illustrated (SI) and decided that some further comments would be useful.

Probably the most important question you asked me was whether the letter containing the incorrect statements being sent to SI damaged World Sailing's reputation.

I consider that the incorrect statements in the letter to SI were embarrassing especially as it was sent to SI who has been very critical and unsupportive of WS over the 4 years that I have been on the Board. Any correction of error could have been handled more effectively if the reactions and subsequent responses by Gary and Scott had been more considered.

I don't think that the letter incorrectly stating that the comments attributed to Scott and Gary was damaging to the reputation per se but the resulting actions by Scott and Gary were definitely more problematic for the organisation.

The subsequent public airing of the disagreement between three directors and the announcement of an ethics complaint against the President by them was damaging. The obvious discord between board members and inability to resolve it caused questions from sponsors. In particular the interview by Mikkel Thommessen with Gary, which was recorded and played back over social media extended awareness of the complaint to the Ethics Commission by two board members against the President to a much wider audience.

As I said I think there were a number of mistakes made - none of which was intentional or unethical. They are just human errors which occur from time to time.

The first mistake was Gary and Scott not reviewing the SI broadcast when the concern about misinformation on SI about them was first raised by email to the board on 26th February and identified as a matter the board would discuss in Board in Board only time during the February meeting.

As a result of this lack of review they couldn't respond to the queries and points made in Board only time on the 28th February and then couldn't confirm or otherwise the letter which was drafted overnight and discussed at the Board on the 29th.

Despite asking for the letter not to be sent until after Gary had reviewed the SI video, he still did not immediately review the video and had not reviewed by the time the letter was sent on March 2.

The mistake Kim made was to ask the office staff to send the letter assuming that as he had heard nothing that there was no issue. He should have confirmed with Gary and Scott that they had listened to the video and were happy for the letter to be sent.

Personally I find it very unusual that two board members would make a complaint to the Ethic Commission about another board member in such circumstances and even more disconcerting that they would announce this complaint publicly. There have been questions raised about the rationale for this action, especially given this is an election year but I have no opinion on their motives in this respect and have not been able to discuss with them.

I hope this clarification is helpful and if you wish to have another call please let me know
